- A. Applicant must be a graduate or graduating from Heritage Hills High School
- B. Applicant must have completed one full school year at Heritage Hills High School
- C. Applicant must be planning to attend an accredited post secondary school and be a full time student
- D. Application must be submitted on time
- E. Scholarship proceeds shall be paid directly to the financial office of the post secondary institution and will be paid annually with distribution paying half in the fall semester and half in the spring semester semester and be applied toward tuition and institutional expenses

Criteria for Merit Scholarship

- A. Applicant must maintain a 3.333 GPA or above, to be averaged over seven (7) semesters of high school
- B. Applicant must meet the minimum criteria for the established category as listed above

<u>Criteria for Financial Grant Scholarship</u>

- A. Applicant must maintain a 3.0 GPA or above, averaged over seven (7) semesters of high school
- B. Applicant must show the student's and parent's adjusted gross income as shown on their FAFSA application
- C. Applicant must meet the minimum criteria for the established category as listed above

Criteria for the Ken Dilger Scholarship

- A. Applicant must have been a participant in an athletic program at least three of the four years in high school including his/her senior year. Athletic program participants include players, managers, and cheerleaders.
- B. Applicant must meet the minimum criteria for the established category as listed above

Criteria for Rosbottom Memorial Scholarship

- A. Applicant must be a good citizen, demonstrate academic excellence, exhibit financial need, and have a good moral character.
- B. Applicant must intend to attend Purdue University
- C. Applicant must show the student's and parent's adjusted gross income as shown on their FAFSA application
- D. Applicant must meet the minimum criteria for the established category as listed above

Criteria for John and Gerry Varner Scholarship

- A. Applicant must be a good citizen, demonstrate academic excellence, exhibit financial need, and have a good moral character.
- B. Applicant must show the student's and parent's adjusted gross income as shown on their FAFSA application
- C. Applicant must meet the minimum criteria for the established category as listed above

Criteria for the Youngblood Family Scholarship

- A. Applicant must indicate one of the following categories: technical, financial need, or merit. The scholarship began in 2004 with the technical category and will continue to rotate each year.
- B. Applicant must meet the minimum criteria for the established category as listed above

Criteria for Discretionary Scholarship/Grant

- A. Applicant must meet the minimum criteria for the established category at listed above
- B. This award may be given in any area: technical, financial need, or merit
- C. This award may not exceed two in any given year

Criteria for the Service Scholarship

A. Applicant must meet the minimum criteria for the established category as listed above

Criteria for the Technical Scholarship

- A. Applicant must maintain a 2.0 grade point average or above, averaged over seven (7) semesters of high school
- B. Applicant must enroll in a two (2) year technical school
- C. Applicant must meet the minimum criteria for the established category as listed above

Criteria for the Ruth and Hilbert Braun Memorial Scholarship

- B. Applicant must be active in extracurricular activities, involved in community and church, dependable, hardworking, responsible and ambitious
- C. Applicant must meet the minimum criteria for the established category as listed above

Criteria for the Thomas D. Brumett Memorial Scholarship

- A. Applicant must be a senior who has not received any other scholarship as of the date of the selection process

- E. The scholarship is affiliated with the Spencer County Community Foundation and was matched one for two with the Mulzer Fund

Criteria for the David L. Schlachter Memorial Scholarship

- A. Applicant must be a senior who attended Nancy Hanks Elementary School
- B. Applicant must be pursuing a 4 year degree in education or agriculture
- C. Applicant must have a minimum 3.0 GPA on a 4.0 scale
- D. Applicant must show participation and leadership in extracurricular activities, school activities, and community organization.
- E. Applicant must meet the minimum criteria for the established category as listed above
- F. Financial need is not a requirement but may be considered secondary to all other criteria

<u>Criteria for the Edwin Tretter Memorial Scholarship</u>

- A. Applicant must be a senior who attended Nancy Hanks Elementary School
- B. Applicant must have a minimum 2.5 GPA
- C. Applicant must be planning to attend a 2 or 4 year college, university, or technical school
- D. Applicant must exhibit good moral character and demonstrate service to others in school, community, and church
- E. Applicant must meet the minimum criteria for the established category as listed above

Criteria for the Elmer and Flora Winkler Memorial Scholarship
